Southern California Edison Company (SCE), San Diego Gas & Electric Company® (SDG&E®), and the California Public Utilities Commission (CPUC) would like to hear from you. You are invited to participate in a Public Forum, also called a Public Participation Hearing (PPH), about SCE and SDG&E's Joint Application for the 2021 Nuclear Decommissioning Cost Triennial Proceeding.

This Public Forum is part of a formal proceeding that will be transcribed and placed into the formal record so the CPUC can decide about SCE and SDG&E's joint application. You can make comments and raise concerns to the CPUC Administrative Law Judge overseeing this application.

WHY AM I RECEIVING THIS NOTICE?

On February 28, 2022, SCE and SDG&E filed their Joint Application For the 2021 Nuclear Decommissioning Triennial Proceeding (A.22-02-016) with the CPUC. In the joint application, applicants seek approvals related to the costs of decommissioning the San Onofre Nuclear Generating Station (SONGS) and the Palo Verde Nuclear Generating Station (PVNGS). SDG&E individually asks the CPUC to approve decommissioning cost estimates of \$45 million for SONGS Unit 1, \$942 million for SONGS Units 2 and 3 and \$19 million for SDG&E-only costs. Based on these decommissioning cost estimates and the balances in SDG&E is not requesting a rate increase in this application.

SDG&E also asks the CPUC to approve as reasonable \$1 million in recorded costs for decommissioning projects at SONGS Unit 1

completed between 2018 and 2020, \$118 million in recorded costs for decommissioning projects SONGS Units 2 and 3 completed between 2018 and 2020 and \$5 million in SDG&E-only costs incurred between 2018 and 2020. SDG&E also asks the CPUC to approve depositing proceeds from litigation with the U.S. Department of Energy into the nuclear decommissioning trusts.

SCE individually asks the CPUC to approve decommissioning cost estimates of \$226 million for SONGS Unit 1; \$4.712 billion for SONGS Units 2 and 3; and \$594 million for PVNGS Units 1, 2 and 3. Based on these decommissioning cost estimates and the balances in SCE's nuclear decommissioning trusts, SCE is not requesting a rate increase in this application.

SCE also asks the CPUC to approve as reasonable \$3 million in recorded costs for decommissioning projects at SONGS Unit 1 completed between 2018 and 2020 and \$607 million in recorded costs for decommissioning projects SONGS Units 2 and 3 completed between 2018 and 2020. SCE also asks the CPUC to approve depositing proceeds from litigation with the U.S. Department of Energy into the nuclear decommissioning trusts.

WHY DID SCE AND SDG&F FILE THE JOINT APPLICATION?

The CPUC requires utilities that own nuclear generating facilities to file nuclear decommissioning cost proceeding applications every three years. SCE and SDG&E's last nuclear decommissioning cost triennial proceeding was filed in 2018. SCE and SDG&E co-own SONGS Unit 1. SONGS Units 2 and 3 are co-owned by SCE, SDG&E, the City of Anaheim, and the City of Riverside.

HOW COULD THIS AFFECT MY MONTHLY ELECTRIC RATES?

SDG&E is not requesting any changes to electric rates in this proceeding.

HOW DOES THE REST OF THIS PROCESS WORK?

This Application has been assigned to a CPUC Administrative Law Judge (ALJ) who will consider proposals and evidence presented during the formal hearing process. The ALJ will issue a proposed decision that may adopt the joint Application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review the joint Application, including the Public Advocates Office. The Public Advocates Office is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate or service consistent with reliable and safe service levels.
