PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

SUBJECT: ADDITION OF BROADWAY STREET 4” STEEL GAS PIPELINE (CITY OF CHULA VISTA) TO THE ELECTRIC AND GAS PRELIMINARY STATEMENTS FOR HAZARDOUS WASTE SUBSTANCE CLEANUP

San Diego Gas & Electric Company (SDG&E) hereby transmits for filing revisions to its electric and gas tariffs as reflected in Attachments A and B, respectively.

PURPOSE

The purpose of this filing is to add Broadway Street 4” Steel Gas Pipeline (in the City of Chula Vista) to the list of Covered Hazardous Substance Cleanup Sites contained in Section VI.B.1.c.(3) of SDG&E’s Electric Preliminary Statement and in Section VIII.E.1.c.(3) of SDG&E’s Gas Preliminary Statement. This Advice Letter is being filed in compliance with California Public Utilities Commission (Commission) Decision (D.) 94-05-020 in Application (A.) 91-04-044.

BACKGROUND

D.94-05-020 established a new procedure for the recovery of electric and gas hazardous waste cleanup program expenses. The procedure applies to manufactured gas plant sites, presently identified Federal Superfund sites, and other sites identified by the utilities. In addition, SDG&E may add sites to the procedure by filing an advice letter requesting such treatment which provides the following information: 1) name of the site; 2) location of the site; 3) the source, nature, and approximate date of the contamination; 4) utility operations (historic and current) at the site, if any; and 5) environmental agency actions and oversight regarding the site, if any. The ability to add sites to the procedure was confirmed by Commission Resolution E-3419.

The relevant information for the Broadway Street Pipeline is as follows:

1. Name: Broadway Street 4” Steel Gas Pipeline
2. Location: Broadway Street, Chula Vista, California

3. Source, Nature, and Approximate Date of Contamination: Approximately 1,500 feet of 4" Steel 1928 vintage gas pipeline with a coal tar asbestos containing pipe wrap. This previously abandoned gas pipeline is being removed by SDG&E this year (2009) as it is in conflict with the City's proposed storm drains and sewer improvement plans.
4. Utility Operations (historic and current): This is a previously abandoned gas pipeline with coal tar asbestos containing pipe wrap. The Site is located on Broadway from the border of National City to D Street in the incorporated city of Chula Vista, CA.
5. Environmental Agency Actions and Oversight: San Diego County Department of Environmental Health Local Enforcement Agency has closed Landfill jurisdiction and oversight under Title 27 of California Code of Regulations.
6. Costs: The closed burn ash landfill cleanup costs that SDG&E is seeking to recover through the procedure are not being recovered through base rates or through any other recovery procedure. All cleanup costs included by SDG&E in the procedure will be hazardous and non-hazardous waste cleanup costs found appropriate for recovery in the Hazardous Substance Cleanup Cost Recovery Collaborative Report, dated November 19, 1993.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.

EFFECTIVE DATE

SDG&E believes that this filing is subject to Energy Division disposition and should be classified as Tier 2 (effective after staff approval) pursuant to GO 96-B. Therefore SDG&E respectfully requests that this advice letter become effective July 25, 2009, which is 30 calendar days after the date filed.

PROTEST

Anyone may protest this advice letter to the Commission. The protest must state the grounds upon which it is based, including such items as financial and service impacts, and should be submitted expeditiously. The protest must be made in writing and received within 20 days of the date this advice letter was filed with the CPUC. There is no restriction on who may file a protest.
