The total rates presented reflect the UDC rates associated with service under Schedule DR-TOU - CARE and the generation rates associated with Schedule EICC. In addition, they include the 20% discount and exemption from the CARE surcharge identified in Schedule E-CARE. The UDC rate by rate component presented is associated with service under Schedule DR-TOU - CARE as presented in the utility's tariff book, which includes the TRAC rate component identified separately from the PPP rate component.
