Dear Resident or Property Owner:

The Cleveland National Forest Power Line Replacement Projects received two major regulatory approvals when the California Public Utilities Commission approved the Project on May 26, 2016 and the United States Forest Service granted a Record of Decision for this vital electric infrastructure project on March 11, 2016.

Construction of the Project is ongoing, and you may have received prior notification about the start of construction on March 18, 2019. In addition, you may have received prior notification on February 20, 2020 about weekend work between March 7 and April 12, 2020. Due to recent weather conditions, the wire stringing operations over Interstate 8 have been delayed. Therefore, San Diego Gas & Electric Company (SDG&E®) and its contractor Crux Subsurface, Inc. are anticipating that construction activities may need to occur within 300 feet of your parcel on the following upcoming weekends: April 18 and 19, April 25 and 26, May 2 and 3, May 9 and 10, May 16 and 17, May 30 and 31, and/or June 6 and 7. Construction activities will be conducted between 11:00 p.m. on Saturday to 2:00 p.m. on Sunday for these dates. In addition, the Interstate 8 on-ramps and off-ramps at Sunrise Highway may be intermittently closed from 3:00 a.m. to 2:00 p.m. on these weekends. Please note that construction activities are not anticipated to occur every weekend listed previously, but work could occur on any weekend.

In accordance with Mitigation Measure (MM) NOI-4 of the Cleveland National Forest Power Line Replacement Projects' Mitigation Monitoring, Compliance and Reporting Program, SDG&E must notify all property owners within 300 feet in advance of planned construction activities that take place outside of the allowable construction hours, which are between 7:00 a.m. and 7:00 p.m. Monday through Saturday. This letter is intended to fulfill the requirements of MM NOI-4 by providing you with advance notice of the intent to conduct the construction activities described above.

During this challenging time, SDG&E is committed to doing everything it can to minimize customer disruptions. Should a planned outage be required, SDG&E will contact you via telephone with information on how to receive supplemental power to your home. If you currently own a generator, other arrangements may be made. We will endeavor to keep outages to a minimum and for as short a duration as possible while completing this critical wildfire safety work.
