Re: San Diego Gas & Electric Company, 2021 Annual TRBAA Rate Revision, Docket No. ER21-___-000

Dear Secretary Bose:

Pursuant to Section 205(d) of the Federal Power Act, ¹ and Section 35.13 of the Federal Energy Regulatory Commission's ("FERC" or "Commission") regulations, ² San Diego Gas & Electric Company ("SDG&E") submits an adjustment to the rate and revenue requirement under its Transmission Owner ("TO") Tariff, FERC Electric Tariff Volume No. 11. This adjustment, made pursuant to SDG&E's TO Tariff, is SDG&E's annual update to the Transmission Revenue Balancing Account Adjustment ("TRBAA").³

This filing updates the TRBAA rate for retail End-Use customers ("retail") and the TRBAA to be used by the California Independent System Operator Corporation ("CAISO") in calculating CAISO's Transmission Access Charge ("TAC") ("CAISO wholesale"). The requested effective date for this adjustment is January 1, 2021.⁴

I. REVISIONS TO THE TRBAA AND TRBAA RATE

The TRBAA is the ratemaking mechanism designed to ensure that Transmission Revenue Credits flow through to transmission customers. Section 5.5 of SDG&E's TO Tariff identifies the items subject to the Transmission Revenue Balancing Account Adjustment and sets forth

SDG&E's most recent annual TRBAA update filing was accepted by the Commission effective January 1, 2020, in Docket No. ER20-524-000, by delegation letter order dated January 8, 2020.

how the TRBAA rate is to be revised annually. This annual revision is based on the recorded balance in:

- The TRBAA as of September 30 of the current year;
- A forecast of the expected Transmission Revenue Credit d to be received in the following year; and
- Franchise Fees/Uncollectibles.

The retail and CAISO wholesale TRBAA are shown in Statement BK-1 and Statement BK-2, respectively. The final 2021 retail and CAISO wholesale TRBAA is a revenue credit of approximately \$21.6 million.⁵ Below is a summary of the TRBAA and the primary reason(s) for the change in TRBAA.

TRBAA Balance @ 9/30/2020= \$(5,041,424)Revenue Credits Forecast= \$(16,368,948)Franchise Fees & Uncollectibles= \$(256,175)Total Retail TRBAA= \$(21,666,547)Less: Uncollectible Adjustment= \$(36,184)Total Wholesale TRBAA= \$(21,630,364)

The change is roughly \$2.2 million more than the 2020 retail and CAISO wholesale TRBAA of approximately \$19.4 million.⁶ The difference is primarily attributable to the following:

- 1) In the 2020 TRBAA filing, the 09/30/19 balance was an over-collection of approximately \$3.8 million. As noted above, the 09/30/20 balance is an over-collection of approximately \$5.0 million, a difference of \$1.2 million.
- 2) The 2021 net transmission revenue credit forecast is approximately \$1.0 million greater than the 2020 forecast, mainly because of an anticipated higher level of wheeling activities for 2021.

The revised TRBAA Rate is (\$0.00123) per kWh, compared to the current rate of (\$0.00108) per kWh.

Wholesale rates reflecting the proposed wholesale TRBAA will be contained in SDG&E's TO5 Cycle 3 formula rate informational filing, which will be submitted by December 1, 2020 under its TO Tariff Appendix VIII, Attachment 1.

II. REVISED TO TARIFF

The revised TRBAA and change to the TRBAA Rate applicable to End-Users described above are reflected in the revised Appendices I and III to SDG&E's TO Tariff submitted in this filing.

III. EFFECTIVE DATE

SDG&E's TO Tariff provides that TRBAA revisions become effective January 1, 2021. SDG&E respectfully requests the Commission assign the TRBAA revisions an effective date of January 1, 2021.

IV. OTHER MATTERS

No expenses or costs included in these rates have been alleged or judged in any administrative or judicial proceeding to be illegal, duplicative, or unnecessary costs that are demonstrably the product of discriminatory employment practices.

SDG&E believes that the provided information contained provides a sufficient basis to accept this filing, and that the filing conforms to any and all rules of general applicability and to any Commission order. SDG&E has served electronic copies to the official service list in Docket No, ER19-221 (SDG&E's TO5 formula rate filing), and the CAISO.
