



SDG&E®: Bundled Electric Rate Change Alert

In January 2025, San Diego Gas & Electric® (SDG&E®) filed Advice Letter 4588-E and 4588-E-A to consolidate previously approved electric rate change requests. As a result, SDG&E's bundled residential average electric rates will increase by approximately 1.1 cents/kWh or 3.0% from 38.5 cents/kWh to 39.7 cents/kWh.¹

A bundled customer is one who receives both their electric delivery and electric generation from SDG&E. Average residential monthly bill impacts for a typical bundled customer are shown below.

- SDG&E's General Rate Case decision authorizes investments needed in SDG&E's infrastructure to enable the clean energy transition required by the state. It also provides funding for the forecasted costs of the safe and reliable operations and maintenance of the region's electric system.
- The impact of the General Rate Case decision is partially offset by federal investment tax credits we received for our energy storage projects.

SDG&E®: Unbundled Electric Rate Change Alert

In January 2025, San Diego Gas & Electric® (SDG&E®) filed Advice Letter 4588-E and 4588-E-A to consolidate previously approved electric rate change requests. As a result, SDG&E's residential average electric delivery rates will increase by approximately 0.5 cents/kWh or 2.3% from 23.3 cents/kWh to 23.9 cents/kWh.¹

An unbundled customer is someone who receives their electric generation from another provider such as a Community Choice Aggregator (CCA). For additional information on your electric generation rate, please reach out to your electricity provider.² Average residential monthly bill impacts for a typical unbundled customer are shown below.
