

Bundled Electric Rate Change Alert

In August 2025, San Diego Gas & Electric® (SDG&E®) filed [Advice Letter 4701-E](#) revising electric rates to reflect the removal of various programs from electric rates. As a result, SDG&E's bundled residential average electric rates will decrease by approximately 0.5 cents/kWh or -1.2% from 41.5 cents/kWh to 41.0 cents/kWh.¹

A bundled customer is one who receives both their electric delivery and electric generation from SDG&E. Average residential monthly bill impacts for a typical bundled customer are shown below. The changes in CARE and Non-CARE electric bills are primarily driven by the implementation of the BSC.

Primary drivers for this rate decrease include the following:

- Roll-off of costs associated with unexpected catastrophic events including the COVID-19 pandemic that have now been recovered.
- Roll-off of 2024 costs collected on behalf of San Diego Regional Energy Network (SDREN), who provide Energy Efficiency programs to customers that have now been recovered.

In addition, as part of AL 4701-E, SDG&E will also be updating rates to reflect the recently adopted Base Services Charge ("BSC"). The BSC is a reallocation of existing costs. These costs were previously included in the price per kWh for electric delivery but will now be collected in a separate line item on a customer bill. As a result of this change, residential per kWh rates will be reduced. Any change in individual customer's bills will depend on their usage. Unbundled Electric Rate Change Alert

In August 2025, San Diego Gas & Electric® (SDG&E®) filed [Advice Letter 4701-E](#) revising electric rates to reflect the removal of various programs from electric rates. As a result, SDG&E's residential average electric delivery rates will decrease by approximately 0.5 cents/kWh or -2.0% from 25.8 cents/kWh to 25.2 cents/kWh.¹

An unbundled customer is someone who receives their electric generation from another provider such as a Community Choice Aggregator (CCA). For additional information on your electric generation rate, please reach out to your electricity generator.² Average residential monthly bill impacts for a typical unbundled customer are shown below.
