Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act and Sections 35.13 and 385.205 of the Federal energy Regulatory Commission's ("Commission" or "FERC") regulations,<sup>1</sup> San Diego Gas & Electric Company ("SDG&E") proposes minor revisions to SDG&E's previously approved Fifth Transmission Owner Formula Rate, Appendix VIII of SDG&E's Transmission Owner Tariff ("TO5 Formula Rate") Cycle 2 Order No.864 compliance filing submittal accepted on March 21, 2022, effective January 27, 2020.

On December 8, 2022, in Docket ER20-1742, SDG&E submitted minor revisions to the Order 864 compliance filing. SDG&E withdrew that filing on January 6, 2023 due to errors in the eTariff filing process. In its withdrawal letter, SDG&E stated that it would re-submit the revised Attachment 2 to Appendix VIII of its transmission Owner Tariff as a Section 205 filing.

# I. MINOR REVISIONS

- Tab AR-1 columns a and b heading were switched to correspond with the cell references in tab 864-3. Footnotes 2 and 3 were edited accordingly.
- Tabs 864-1 and 864-3; Col. 9 heading description was changed to "SDG&E Records" to avoid the voluminous submission of all the annual Order 864 tabs for the Cumulative Amortization of Excess/Deficient ADIT.
