



## SDG&E - SDCP

### Joint Rate Comparisons

As a part of our shared commitment to provide energy options to our customers, San Diego Community Power (SDCP) and San Diego Gas & Electric® (SDG&E®) have jointly created a comparison of our typical electric rates, average monthly bills and electric generation power sources.

SDG&E implemented adjustments to its electric rates effective January 1, 2022, and again on February 1, 2022. SDCP updated its electric rates on February 1, 2022. The California Public Utilities Commission requires that this comparison be posted online within 60 days of each rate change. In order to minimize confusion associated with multiple updates, SDG&E and SDCP requested and received an extension of time to post this rate comparison, which reflects both January and February rate adjustments, no later than April 2, 2022.

## Definition of Terms

**Power Source** is the mix of energy resources for generating electricity. This makes up the electric power generation mix that is purchased or generated by your provider and delivered to you. Your electric power may be a mix of renewable energy, natural gas and other sources.

**Generation Rate** is the cost of generating and/or purchasing electricity to power your home or business. The generation rate varies based on your energy provider and the resources included in your energy provider’s generation power source.

**SDG&E Delivery Rate** is SDG&E’s charge to deliver electricity to your home or business. The electric delivery rate may vary depending on your rate and electricity use, however, it is charged equally to customers regardless of who provides their electric generation.

**SDG&E PCIA & FF** represents the **Power Charge Indifference Adjustment (PCIA)** and **Franchise Fees (FF)**.

- The PCIA is a charge to recover costs associated with power purchases made on behalf of customers, prior to a customer’s switch to a CCA. The PCIA also applies to customers that subscribe to EcoChoice<sup>SM</sup>.
- The FF is a surcharge applied to electricity transported over SDG&E systems that are constructed in public streets and highways. SDG&E collects the surcharge from customers and remits them to the appropriate municipality. The surcharge is charged equally to customers regardless of who provides their electric generation.
- The PCIA and the SDG&E commodity portion of the FF are included within the generation rate of SDG&E’s standard bundled service.

## RESIDENTIAL

The residential rate comparisons exclude the California Climate Credit from the State of California which is issued twice a year to residential customers.
