### Joint Rate Comparisons

As a part of our shared commitment to provide energy options to our customers, San Diego Community Power (SDCP) and San Diego Gas & Electric® (SDG&E®) have jointly created a comparison of our typical electric rates, average monthly bills and electric generation power sources. SDG&E implemented adjustments to its electric rates effective February 1, 2025. SDCP updated its electric rates on February 1, 2025. The California Public Utilities Commission requires that this comparison be posted online within 60 days of each rate change.

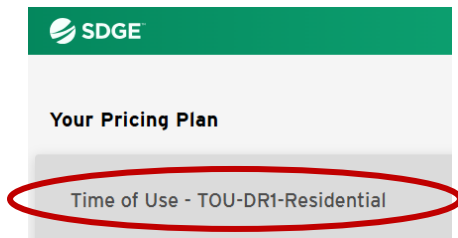

## Definition of Terms

**Power Source** is the mix of energy resources for generating electricity. This makes up the electric power generation mix that is purchased or generated by your provider and delivered to you. Your electric power may be a mix of renewable energy, natural gas and other sources.

**Generation Rate** is the cost of generating and/or purchasing electricity to power your home or business. The generation rate varies based on your energy provider and the resources included in your energy provider’s generation power source.

**SDG&E Delivery Rate** is SDG&E’s charge to deliver electricity to your home or business. The electric delivery rate may vary depending on your rate and electricity use, however, it is charged equally to customers regardless of who provides their electric generation.

**Power Charge Indifference Adjustment (PCIA)** is a charge to ensure that both SDG&E customers and those who have left SDG&E service to purchase electricity from other providers pay the above market costs for generation resources that were procured by SDG&E on their behalf. “Above market” refers to the difference between what the utility pays for electric generation and current market prices for the sale of those resources.

**Franchise Fees (FF)** are the surcharges applied to electricity transported over SDG&E systems that are constructed in public streets and highways. SDG&E collects the surcharge from customers and remits them to the appropriate municipality. This is charged equally to customers regardless of who provides their electric generation.

The unbundled **Renewable Energy Credits (RECs)** retired in association with SDCP’s portfolio were produced by an eligible renewable wind resource. The resource was built before the state’s location-based renewable energy law took effect. SDCP received these RECs from SDG&E via a state-approved allocation process. Thus, the unbundled RECs are not reflected in the SDCP renewable %.

## RESIDENTIAL

The residential rate comparisons exclude the California Climate Credit from the State of California which is issued twice a year to residential customers.
