The following questions relate to pages 16 to 23 of Exhibit SDG&E-02 in Investigation No. 12-10-013 (SDG&E's Testimony Providing Information Requested in Administrative Law Judge's December 10, 2012 Ruling Requesting Additional Testimony Pertaining to Twenty Five Questions), which addressed Questions 15 to 20 posed by the ALJ and related issues.

Where reasonably practical, provide all requested workpapers in electronic Excel-compatible format with data and formulae intact and functioning.

- (1) Answer the following questions regarding “costs of replacement energy” and “replacement energy costs” as SDG&E interprets those terms in Exhibit SDG&E-02 in responding to Questions 16 to 19:
 - a. What does SDG&E estimate the total of these costs was during 2012? Provide data and workpapers documenting these estimates.
 - b. What is SDG&E's position regarding the ratemaking treatment of such costs (e.g., the crediting of such costs to ratepayers)?

SDG&E Response:

- a. Total costs for replacement energy as referenced in Exhibit SDG&E-02 are estimated at \$76,540,010 for 2012. See attached **redacted** excel file entitled “SONGS OII_01-31-13.xlsx” for the data and workpapers documenting this estimate.
- b. SDG&E is tracking all replacement energy costs since January 1, 2012 in the SONGS Outage Memorandum Account (SONGS OMA) pursuant to the OII and expects the ratemaking treatment of these costs to be as determined in either Phase 1 or Phase 2 of the OII.
