**APPLICATION OF SAN DIEGO GAS & ELECTRIC COMPANY (U 902-E)  
FOR AUTHORITY TO UPDATE  
COST ALLOCATION AND ELECTRIC RATE DESIGN**

San Diego Gas & Electric Company (SDG&E) hereby submits its *Application For Authority To Update Cost Allocation And Electric Rate Design*, effective November 1, 2009 (Application). SDG&E submits this Application in accordance with the Commission’s Rate Case Plan as set forth in Decision (D.) 89-01-040, as modified by D.02-10-039, D.95-09-020 and D.94-08-023, and, as discussed below, D.08-02-034.

**I. OVERVIEW OF APPLICATION**

The submission of this Application, also known as a “Rate Design Window” (RDW), is prompted in part by the requirements of the settlement of SDG&E’s 2008 Test Year General Rate Case Phase 2 Application (A.07-01-047), as adopted in D.08-02-034 (Settlement). In addition to the Settlement requirements, SDG&E is also proposing a limited number of other changes, as follows:

**A. Settlement Compliance Elements:**

1. Presentation of SDG&E’s Commercial and Industrial class split proposal at 500 kW (Witness Hansen);
2. Presentation of revenue allocation results for SDG&E’s Commercial and Industrial class split proposal (Witness Parsons); and
3. Presentation of the Class Split Study which was submitted to parties on August 1, 2008 (Witness Hansen).

**B. Changes as proposed by SDG&E:**

1. General rate updates and design methodologies for each rate schedule (Witness Hansen);

2. Reduction of the Residential Baseline Allowance (Witness Hansen);
3. Elimination of Residential and Small Commercial Customer Time of Use Metering Charges (Witness Hansen);
4. Design of California Solar Initiative rates applicable to Non-Exempt Residential Customers (Witness Hansen);
5. Proposal of a new Sports Field Outdoor Lighting tariff (Witness Hansen);
6. A number of tariff “clean up” changes (Witness Hansen);
7. Update to the Sales Forecast (Witness Katsapis);
8. Changes to the Residential Peak Time Rebate tariff (Witness Spurgeon);
9. Proposal to eliminate the implementation of the Peak Time Rebate for small non-residential customers (Witness Spurgeon); and
10. Changes to the Default Critical Peak Pricing tariff (Witness Spurgeon).

SDG&E is not proposing changes to marginal costs in this RDW.

## **II. EFFECT ON DISTRIBUTION AND COMMODITY REVENUES AND RATES**

If approved, SDG&E’s RDW proposals would maintain the current revenue allocation methodology for distribution and commodity revenues that are based on the Settlement as adopted in D.08-02-034. In that decision, no specific marginal costs for revenue allocation were adopted by the Commission, but rather only class revenue requirements which was based on an underlying settlement revenue allocation methodology. SDG&E normally submits comprehensive new or revised marginal distribution and commodity cost studies either every three years in RDW applications, or as Phase 2 of a General Rate Case application. These marginal cost studies then form the basis of subsequent distribution and commodity revenue allocation proposals. In the RDW Applications where SDG&E does not propose new marginal costs, the existing distribution and commodity revenue allocations are updated, but, marginal costs are not updated or revised. Since SDG&E’s last adopted revenue allocation was in year 2008 (filed in A.07-01-047), SDG&E does not propose revised marginal costs for this RDW Application. On a system average and class average basis, the proposals contained within

this application will result in overall rate decreases due to SDG&E's proposed use of an updated sales forecast reflecting Test Year 2009. However, certain proposals within the residential class would result in increased energy costs for customers using less than 130% of the baseline level of kWh and decreased energy costs for customers above this level.

### **III. ADDITIONAL INFORMATION**

#### **A. Rule 1.9, 1.10, 3.2 (b), 3.2 (c), and 3.2 (d)**

In compliance with the Commission's Rules of Practice and Procedure, SDG&E will, within ten days after filing this Application, mail a notice to the state of California and to the cities and counties in its service territory and to all those persons listed in Appendix E. Also within ten days, SDG&E will post in its offices and publish in newspapers of general circulation in each county in its service territory notice of this Application. Within 45 days of the filing of this Application, SDG&E will provide such notice to all of its customers along with the regular bills sent to these customers. SDG&E will also serve the Notice of Availability of this Application and supporting Exhibits on all parties of record in A.07-01-047 (SDG&E's 2008 Test Year General Rate Case Phase 2 Application).

#### **B. Rule 2.1**

This Application is filed pursuant to Section 454 of the California Public Utilities Code, and in compliance with the Commission's Rules of Practice and Procedure.

The Applicant is a corporation organized and existing under the laws of the State of California. It is a gas and electric corporation subject to the jurisdiction of this Commission and is engaged in the business of providing public utility electric service to portions of southern Orange County and gas and electric service throughout San Diego County.

SDG&E proposes that this RDW Application be treated as a "ratesetting" proceeding. The issues to be considered are described in SDG&E's Exhibits containing SDG&E's witnesses' prepared direct testimony and are summarized as follows:

- Should the Commission adopt general rate updates and design methodologies for each rate schedule (Chapter 1);
- Should the Commission authorize a new Commercial and Industrial customer class split (Chapter 1);
- Should the Commission approve a reduction of the Residential Baseline Allowance (Chapter 1);
- Should the Residential and Small Commercial Customer Time of Use Metering Charges be eliminated (Chapter 1);
- Should the rate design applicable to the California Solar Initiative be revised for recovery from non-exempt Residential Customers (Chapter 1);
- Should the Commission approve a new Sports Field Outdoor Lighting tariff (Chapter 1);
- Should the Commission approve a number of tariff "clean up" changes (Chapter 1);

- Should SDG&E's sales forecast be accepted (Chapter 2);
- Should SDG&E's revenue allocations be accepted (Chapter 3);
- Are SDG&E's proposed changes to the Residential Peak Time Rebate tariff just and reasonable and should they be adopted (Chapter 4);
- Are SDG&E's proposed changes to the Small, Non-residential Peak Time Rebate tariff consistent with D.08-07-045, just and reasonable, and should they be adopted (Chapter 4); and
- Are SDG&E's proposed changes to the Default Critical Peak Pricing tariff consistent with D.08-07-045, just and reasonable, and should they be adopted (Chapter 4).

SDG&E assumes hearings will be necessary and therefore suggests the following procedural schedule:

**F. Rule 3.2 (a)(4)**

A general description of SDG&E's property was filed with the Commission on October 5, 2001, in connection with Application 01-10-005, and is incorporated herein by reference. A statement of Original Cost and Depreciation Reserve is attached as Appendix C.

**G. Rule 3.2 (a)(5) and (6)**

SDG&E's Summary of Earnings is included in Appendix D.

**H. Rule 3.2 (a)(7)**

For financial statement purposes, depreciation of utility plant has been computed on a straight-line remaining life basis, at rates based on the estimated useful lives of plant properties. For federal income tax accrual purposes, SDG&E generally computes depreciation using the straight-line method for tax property additions prior to 1954, and liberalized depreciation, which includes Class Life and Asset Depreciation Range Systems, on tax property additions after 1954 and prior to 1981. For financial reporting and rate-fixing purposes, "flow through accounting" has been adopted for such properties. For tax property additions in years 1981 through 1986, SDG&E has computed its tax depreciation using the Accelerated Cost Recovery System. For years after 1986, SDG&E has computed its tax depreciation using the Modified Accelerated Cost Recovery Systems and, since 1982, has normalized the effects of the depreciation differences in accordance with the Economic Recovery Tax Act of 1981 and the Tax Reform Act of 1986.

**I. Rule 3.2 (a)(8)**

A copy of SDG&E's most recent proxy statement, dated April 4, 2008, was mailed to the California Public Utilities Commission on April 29, 2008, and is incorporated herein by reference.



**IV. CONCLUSION**

*WHEREFORE, SAN DIEGO GAS & ELECTRIC COMPANY* requests that the Commission 1) authorize the various rate design and revenue allocation proposals described above; 2) authorize SDG&E to implement the rates as proposed herein; and, 3) grant such additional relief as the Commission believes is just and reasonable.

SDG&E is ready to proceed with its 2009 RDW showing.
