

ABOUT THIS FORM

This Application enables San Diego Gas & Electric Company (SDG&E®) customers to apply for Comprehensive Audit Program (Category 2). The Comprehensive Audit Program (Category 2) will offer a detailed analysis and energy saving opportunities with a report to identify specific Energy Efficiency and Demand Response measures identified by the customer and auditor.

CUSTOMER REQUIREMENTS

To be eligible for a Comprehensive Audit (Category 2) assessment from SDG&E's Comprehensive Audit Program, any commercial, industrial, or agricultural customer with a monthly on-peak demand of 100 kilowatts (kW) or greater, servicing the facilities for which the audit is being requested, must:

- Be billed on a commercial, industrial, or agricultural Time of Use rate schedule
- Have appropriate electrical metering billed on intervals, and receive 15-minute interval data
- Have not received an audit from San Diego Gas & Electric Company in the past 3 years
- Customer must have occupied premise for a minimum of 6 months

HOW TO APPLY

Eligible customers must complete, sign, and submit this Application with all required supporting documentation to:

WHAT TO EXPECT

1. SDG&E will review the Application and work with you and your Account Executive (if applicable) to clarify and resolve any outstanding issues.
2. SDG&E will assign an Auditor that best fits the needs of your facility.
3. After the Auditor has been assigned by SDG&E, the Auditor will contact you to schedule a walk-through of your facility to take inventory of your existing energy consuming equipment.
4. At the conclusion of the walk-through, the auditor will analyze the information collected and begin to generate the Category 2 audit report for the selected measures on page xx.
5. Once the final report is completed, the auditor will submit the report to SDG&E for review.
6. Concluding SDG&E review, SDG&E will issue a NTP (Notice to Proceed) to the auditor to commence a final meeting with you and your Account Executive (if applicable) to review the report for selected measures in detail and review the Energy Saving Opportunities identified.
