# NOTICE OF SAN DIEGO GAS & ELECTRIC COMPANY'S RATE INCREASE REQUEST

San Diego Gas & Electric Company's Palomar Decarbonization Demonstration Project  
Application to the California Public Utilities Commission A.25-12-009

## Initialisms you need to know

## What is being requested?

SDG&E is requesting a revenue increase of \$23.4 million to recover costs for its Palomar Decarbonization Demonstration Project through 2031. The project focuses on demonstrating multiple use cases of clean hydrogen to support reducing emissions from power plants. This increase will be phased in through the life of the project.

How would this impact an unbundled customer?<sup>3</sup>

If the request is approved by the CPUC, a typical unbundled residential customer using 400kWh per month would see an average monthly electricity bill increase of approximately \$0.30 or 0.3% per month in 2027, and then \$0.08 or 0.1% per month in 2028.<sup>4</sup> Actual impacts will vary based on usage, pricing plan, and when a customer became an unbundled customer (PCIA vintage).

How would this impact a bundled customer?<sup>5</sup>

If SDG&E's request is approved by the CPUC, a typical customer using 400 kWh per month would see an average monthly electricity bill increase of approximately \$0.29, or 0.2% in 2027, and then \$0.08 or 0.0% in 2028.<sup>6</sup> The actual impact will vary based on usage and pricing plan.
