State Tax Exempt Self-Certification Affidavit

California imposes the Energy Resources Surcharge tax on the consumption of electrical energy purchased from an electric utility. (Rev. C. 40018) Certain customers, including enrolled Indians purchasing and consuming electrical energy on Indian reservations, are exempt from paying this tax. (CCR 2316).

If you are an enrolled Indian purchasing and consuming electrical energy on an Indian reservation you may use this form to self-certify that you are exempt from payment of the Energy Resources Surcharge.
