Reference: Annual Update to Transmission Revenue Balancing Account Adjustment

Dear Mr. Barnes:

On November 1, 2017, San Diego Gas & Electric Company (SDG&E) filed revisions to Appendix III of its Transmission Owner Tariff to reflect the annual update to its Transmission Revenue Balancing Account Adjustment (TRBAA).¹ SDG&E proposes a 2018 TRBAA for purposes of calculating the CAISO TAC of negative \$13,438,211, and a retail TRBAA of negative \$13,461,335, passed through using a TRBAA rate of negative \$0.00070 per kWh. The proposed tariff revisions are accepted for filing, effective January 1, 2018, as requested.

The filing was noticed on November 1, 2017, with comments, protests, or interventions due on or before November 22, 2017. No protests or adverse comments were filed. Notices of intervention and unopposed timely filed motions to intervene are granted pursuant to the operation of Rule 214 of the Commission's Rules of Practice and Procedure (18 C.F.R § 385.214). Any opposed or untimely filed motion to intervene is governed by the provisions of Rule 214.

¹ SDG&E states that the TRBAA is the ratemaking mechanism designed to ensure that Transmission Revenue Credits flow through to transmission customers. SDG&E states that the TRBAA is used by the California Independent System Operator Corporation (CAISO) in calculating its Transmission Access Charge (TAC).
