If you are a residential plug-in electric vehicle driver, and you live in the area served by SDG&E®, then you may qualify for a credit.

To apply, you will need:

- A copy of your California DMV registration card or new vehicle dealer notice of temporary identification
- Your Vehicle Identification Number (VIN)
- SDG&E residential account number found on your billing statement (if applicable)
- To be the registered owner of the vehicle in the state of California with a registered address within the area served by SDG&E.

Vehicle must have been purchased/leased between June 1, 2019, and November 16, 2020, or purchased/leased between March 1, 2019, and May 31, 2019 and had not received the 2019 Electric Vehicle Climate Credit.

- Funding Availability:** The Limited Electric Vehicle Purchase Credit Program (the "Program") has limited funding and is offered on a first-come, first-served basis until funding is depleted or the Program is terminated, whichever comes first. I, the Applicant, understand that submission of my Enrollment Form is not a guarantee of receipt of the Limited Electric Vehicle Purchase Credit from SDG&E, nor is it a guarantee of fund availability. Upon my execution of this Enrollment Form and written notification of SDG&E's approval of my Enrollment Form, I will become eligible to receive the Limited Electric Vehicle Purchase Credit in accordance with the program rules.
- Changes to Limited Electric Vehicle Purchase Credit:** The one-time credit is subject to the jurisdiction of the California Air Resources Board ("CARB") and California Public Utilities Commission ("CPUC"), and shall be subject to such changes or modifications as the CARB and/or CPUC may, from time to time. I agree that SDG&E will not be liable for any damages or compensation of any kind that may result from the changes described in this paragraph.
- Release and Use of Information:** I authorize SDG&E to release my contact and other relevant information to CARB, and the CPUC for purposes related only to my participation in the Program and not for any other commercial use. - Limited Electric Vehicle Purchase Credit:** I understand that I am only eligible for the Limited Electric Vehicle Purchase Credit if I (a) purchased/lease a plug-in electric vehicle registered in my name in the state of California, with a registered address within SDG&E's service territory, and (b) I purchased/leased such plug-in electric vehicle between June 1, 2019, and November 16, 2020. If I purchased/leased an EV between March 1, 2019, and May 31, 2019, and did not already receive the 2019 Electric Vehicle Climate Credit, I am also eligible. I understand if I meet these requirements, I must submit my application no later than November 30, 2020, to be eligible. I agree to provide SDG&E with documents establishing proof of purchase and registration of my plug-in electric vehicle as described in this Enrollment Form.
- No Double Credits:** I understand that the plug-in electric vehicle for which I am applying for the Limited Electric Vehicle Purchase Credit must be registered in my name in the state of California with a registered address within SDG&E's service territory, provided that other persons may be listed on such registration, but only one Application shall be made for each registered plug-in electric vehicle. Applying for multiple Limited Electric Vehicle Purchase Credit for the same car in the same year by different applicants is prohibited.
