# Notice of Property being held by Business

## Notice Details

As the administrator of the State's Unclaimed Property Program, this notice is intended to reunite you with your property **before** it is sent to the State. The business named below has notified our office that it has property that appears to belong to you. For a description of the property, see **"Type of Property"** below. *In the interest of protecting the privacy of potential property owners and giving them an opportunity to claim their property from the holder, we will no longer disclose the specific amount reported by the holder until it is turned over to the state.*

To claim your property, you must contact the business listed below and present proof that you are the owner of the property. Otherwise, the business is required to send your property to the State Controller's Office, Unclaimed Property Division. We urge you to contact the business to claim your property. **To stop your property from being sent to the State, you must contact the business. The State Controller's Office does not have your property at this time.**

If you do not contact the business before **05/31/2020**, the business is required, by law, to send this property to the State Controller's Office (SCO) where you will be entitled to claim it at any time in the future. Please note, if this property is stock or the contents of a safe deposit box, the SCO is required by law to sell the property after a specified time. However, you or your heirs will always be entitled to the net proceeds of the sale. If the contents of the safe deposit box have no commercial value (such as letters or papers) they may be destroyed, but only after the state has held them for a certain period of time.

**Important:** To prevent your property from being sent to the State, you must contact the business by the date indicated above. This contact information is provided to the SCO by the business and is occasionally subject to change.
