

Hybrid and Zero Emission Truck and Bus Voucher Incentive Project (HVIP) Funding for Medium- and Heavy-Duty Zero Emission Vehicles

The California Air Resources Board (CARB) administers several statefunded grant programs to encourage and accelerate the deployment of zero and near-zero emission trucks and buses.

Program Name	HVIP Second Round of Funding
Open Date	Under development; will reopen August 10th at 10am
Due Date	First come, first served
Eligible Vehicles	HVIP Eligible Vehicle Catalog
BEV Per Unit Funding	\$45,000 - \$150,000 depending on weight class; plus an additional 10% for projects in disadvantaged communities, 15% for public transit agencies, or 65% for public schools.
Maximum Funding	Applicants cannot request more than 30 vouchers per year per tax identification number. If stacked with another funding source; the combined incentives cannot exceed 90% of the total vehicle cost (minus taxes and fees) for private entities or 100% of the total vehicle cost (minus taxes and fees) for public entities.
Location	Awardees must commit to operate the vehicle 100% within California for at least 3 years after the voucher redemption date. Class 8 freight trucks, including port drayage trucks, may accrue up to 50% of their mileage each year outside of California without prior approval, as long as goods are being transported to or from California.

HOW TO APPLY

Now is the time to check that the technologies you want and dealers you use are approved. Before August, coordinate with your dealers to make sure they are prepared to submit vouchers on your behalf on August 10. Requesting a voucher will require the following information, and the dealers will submit them on your behalf:

- Approved vehicle (manufacturer, vehicle type, model year, description)
- Quantity
- Weight
- Fleet point of contact (name, company, address, phone, email, FEIN)
- Base voucher amount
- Voucher enhancement (if applicable)
- CA # and DOT #
- Fleet domicile address (if different than the company address)
- VIN (production name may be provided for the first 60 days if VIN is not yet available)
- · Purchase order
- Signed Terms and Conditions Form

Be prepared to provide clarification or additional information within 10 days of submitting your voucher request to maintain its viability. For additional information and assistance, contact HVIP administrative staff:

TIPS & TRICKS FOR A SUCCESSFUL APPLICATION

ASAP! HVIP funding is the most popular electric vehicle grant program in California. As such, available funds will go quickly due to the "first-come, first-served" nature of the program. Work with your dealers early to ensure they are fully prepared to submit on your behalf by 10am on August 10.

Stay up to date! The FAQs on the HVIP website provide clarification as questions are received, and the new implementation manual is now available.

Check for and maintain regulatory compliance prior to application. Fleets must remain compliant at all times with all applicable federal, state, and/or local regulations, and all applicable regulatory advisories.
