

**Service for Residential Customers with Electric Vehicles**

The following are the CARE/Medical Baseline rates associated with service under Schedule EV-TOU-5. This is SDG&E's residential rate for customers with an electric car or use electricity to run a natural gas home fueling pump. The car must be registered with the California Department of Motor Vehicles.
