SDG&E Response 1:

SDG&E complied with the Commission Order by removing costs associated with the Aliso Canyon Storage Facility gas leak incident from the Test Year 2019 general rate case application. The process of removing costs associated with the Aliso Canyon Incident from 2015 and 2016 historical data is described in the testimony of Andrew Steinberg (Exhibit No.: SCG-12). See Section III, with emphasis on Section III.A. for witnesses with O&M forecasts. The process was applied to the Accounting and Finance, Legal, Reg Affairs and External Affairs Testimony, resulting in the necessary adjustments. The supporting documents can be found in workpapers as follows:

SDG&E Response 2:

As described in the response to data request ORA-SDGE-040-FH2, question #1, the legal and claims costs associated with the Aliso Canyon Storage Facility natural gas leak incident ("Aliso Incident") were excluded from the recorded data. Also excluded are legal and claims costs associated with the 2007 wildfires. Costs for the 2007 wildfires are tracked in the WEMA (Wildfire Expense Memorandum Account.) No other costs were excluded from the 2012-2016 recorded data.
