Question 1

1. For sites participating in the Power Your Drive pilot on the Rate-to-Driver billing option:
 - a. Please provide the hourly 8760 load data and prices paid, aggregated across Multi-Unit Dwelling customers.
 - b. Please provide the hourly 8760 load data and prices paid, aggregated across Workplace customers.

SDG&E Response:

SDG&E is providing the responses from “TURN DR-01 Q2.xlsx” and “TURN DR-01 Q7.xlsx”, which are responsive to this question. SDG&E provides these responses consistent with the ALJ’s March 20, 2020 Ruling permitting production by SDG&E of customer information by a Non-Disclosure Agreement to non-market participants.

The attached file “TURN DR-01 Q2 (Confidential).xlsx” contains hourly utilization (load in kW) data by site unique identifiers. The consumption data reflects load billed to site hosts and drivers through PYD. This is the majority of total PYD consumption, but in some cases, metered PYD site usage using facility meters may exceed the levels reported by the EVSP. This excess is billed to the EVSP servicing the site per the terms of the PYD contract since an appropriate driver and session is not identifiable. The load billed to the EVSP is not included in this data set.

The attached file “TURN DR-01 Q7 (Updated).xlsx” provides the price per kWh per site per hour that pricing was enabled in the same format and site nomenclature as the attached “TURN DR-01 Q2 (Confidential).xlsx”.

Question 4

SDG&E Response:

The WP in the Site ID indicates Workplace.

SDG&E also is correcting the response provided in the previous data request with the following information. Two additional sites have been identified as having site host fees. Additionally, the statement on how other Rate-to-Host (“RtH”) sites are treated was erroneously communicated in the previous response and is corrected to “No other ...”. These changes are marked in redlines below:

WP180003	Charges \$1.00 per hour while charging and after 4 hours (regardless of charging) it costs \$3.00 per hour with a max of \$50 per session.

PYD Electric Vehicle Service Provider (“EVSP”) and site hosts set the pricing that RtH drivers receive. RtH pricing information is subject to change, and modifications may be made without notifying SDG&E in accordance with the agreement between the site host and the EVSPs.
