Pursuant to the California Public Utilities Commission (CPUC) Resolution WSD-011, issued on February 16, 2021, and in accordance with the Office of Energy Infrastructure Safety's (Energy Safety) updated guidance on January 30, 2025 (V4.01), SDG&E hereby submits its Quarterly Data Report (QDR) for the period October 1, 2025, through December 31, 2025 (Q4 2025).
