The total rates presented reflect the UDC rates associated with service under Schedule DR-TOU/DR-TOU-DER - CARE and the generation rates associated with Schedule EECC. In addition, they include the 20% discount and exemption from the CARE surcharge identified in Schedule E-CARE. The UDC rate by rate component presented is associated with service under Schedule DR-TOU/DR-TOU-DER - CARE as presented in the utility's tariff book, which includes the TRAC rate component identified separately from the PPP rate component.
