

**Schedule DT - SUBMETERED MULTI-FAMILY SERVICE - MOBILEHOME PARK (Closed)**

The following are the CARE rates associated with service under Schedule DT. Schedule DT provides service for multi-family accommodations in a mobilehome park receiving service through a single meter and submetered to all individual tenants. This schedule has been closed since January 1, 1997.
