

Schedule DT-RV - SUBMETERED SERVICE - RECREATIONAL VEHICLE PARKS AND RESIDENTIAL MARINAS

The following are the CARE rates associated with service under Schedule DT-RV. Schedule DT-RV provides domestic electric service to qualifying residents of recreational vehicle (RV) parks and residential marinas through one meter on a single premises and submetered to all RV park and residential marina tenants.
