

SDG&E Variable Speed Pool Pump

\$200 Rebate

Rebate Eligibility

Rebate is valid for pumps installed by July 19, 2021 or earlier if allocated funds are no longer available.

Qualifying variable speed pool pump models must be ENERGY STAR® certified, with a horsepower rating between 1 hp and 3 hp.

Rebate will be applied as a markdown at the point of sale and must be installed by a professional and purchased through a participating retailer or distributor listed below. Pumps cannot be purchased online. Post-purchase rebates are not available. Self-installation is not eligible.

Both SDG&E Residential Customer and Installer must sign and acknowledge program Terms & Conditions provided by the participating retailer or distributor.

Key Terms & Conditions include:

- Limit of one (1) rebate per household
- Single-family residences only. Multi-family is not eligible.
- Existing swimming pools only. No fountains or spas. No new construction.
- Replacement (new) pump must replace the main filtration pump only.
- Replacement (new) pump must replace a single or two-speed existing (old) pump; replacements of existing (old) variable speed pumps are not eligible.
- Replacement (new) equipment must be programmed to operate outside of peak hours. (Peak hours are 4:00 p.m. to 9:00 p.m.)
- Installer must provide program's Notice at Collection document to the residential customer, as part of complying with the California Consumer Privacy Act (CCPA).

SDG&E Variable Speed Pool Pump

Rebate Terms & Conditions

1. To be eligible for a rebate, (a) Customer must be a residential customer on a residential rate with an active meter serviced by SDG&E at the installation address, which Customer occupies, and (b) the product(s) installed must meet the eligibility requirements, and have been purchased only through participating retailers or distributors, as described on sdge.com/rebates and be designed to reduce the consumption of the energy at the installation address. All uses herein of the words “install,” “installation” or similar phrases shall mean complete installation such that the subject products are fully functional.
2. Only the primary person listed on the SDG&E account may apply for the rebate. The listed SDG&E account must be active.
3. The pool pump rebate runs from January 1, 2021 through July 19, 2021, or earlier if allocated funds are no longer available. Rebates are available only for eligible products that are purchased and installed during the 2021 program period. The program may be modified or terminated without prior notice.
4. The rebate amount cannot exceed the product’s purchase price. If the purchase price of the product is less than the rebate amount, then only the lesser amount may be rebated.
5. Customer may not receive a rebate for the same product from more than one California investor-owned utility or third-party energy efficiency program offering rebates, financing or other incentives funded with California Public Utilities Commission (CPUC) Public Goods Charge funds. Without limiting the above, if the product qualifies for a rebate offered by another retailer, distributor and/or manufacturer, any additional rebates are separate from this rebate.
6. If Customer is a tenant, Customer is responsible for obtaining the property owner’s permission to install the eligible products.
7. Only VSD pool pump installations that meet the following requirements are eligible for this rebate:
 - a) The replacement VSD pool pump must be installed at a single-family residence in a pre-existing in-ground pool.
 - b) Both existing and replacement pool pumps must be between 1 hp and 3 hp, with horsepower referring to the (rated) nameplate horsepower before service factor is applied.
 - c) The replacement VSD pool pump must be programmed to operate outside of peak hours. Peak hours are 4:00 PM to 9:00 PM daily.
 - d) All equipment and materials must meet or exceed all applicable local, state and federal standards.
 - e) Existing pumps being replaced must be disposed of, rather than refurbished and sold.
 - f) The eligible VSD pool pump must be programmed with timing and flow rates that both minimize energy use and shift the one-hour or two-hour, high-speed cycle to the off-peak period.
8. Replacement VSD pool pumps must remain in operation for a minimum of five (5) years, and Customer shall not be eligible for any rebates for replacement VSD pool pumps during the 5-year period.
9. Installers must be licensed, bonded and insured as required by California law. Installers must follow all manufacturer installation requirements and meet all applicable standards and regulations including (but not limited to) NEC and the California Title 24 and Title 20 regulations.
10. SDG&E and/or the CPUC, or their designated representative, may contact Customer to schedule Quality Control (QC) inspections. QC inspections occur to ensure that Installers and the installed product meet all installation and eligibility requirements and to evaluate program effectiveness. Customer must allow SDG&E and the CPUC (and their representatives) reasonable access to the listed residence to perform QC inspections. QC inspections must be scheduled within 30 days of Customer contact by SDG&E or the CPUC.
11. SDG&E may contact the Installer to verify purchase and/or installation and may provide the Customer’s name and/or address to complete this verification.
12. The selection of qualifying product(s), selection of manufacturer, dealer, supplier and/or installer, and purchase, installation and ownership/maintenance of the qualifying product(s) referenced in this application are the sole responsibility of Customer, and that the manufacturer, dealer, supplier or installer of these products is not an agent or representative of SDG&E. SDG&E makes no representations regarding manufacturers, dealers, contractors, materials or workmanship. SDG&E MAKES NO WARRANTY, WHETHER EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR ANY PARTICULAR PURPOSE, USE, OR APPLICATION OF THE PRODUCTS.
13. SDG&E has no liability whatsoever concerning (1) the quality, safety and/or installation of the products, including their fitness for any purpose, (2) the estimated energy savings of the products, (3) the workmanship of manufacturer, dealer, supplier, installer or any other third party, (4) the installation or use of the products including, but not limited to, effects on indoor pollutants, or (5) any other matter with respect to the rebate program.
14. To the maximum extent permitted by applicable law, (a) Customer and Installer hereby waive any and all claims against SDG&E, its parent companies, directors, officers, employees, or agents, arising out of activities conducted by or on behalf of SDG&E in connection with this rebate, and (b) SDG&E shall not be liable to Customer or Installer for any type of damages, whether direct, indirect, incidental, consequential, exemplary, reliance, punitive or special damages, including damages for loss of use regardless of the form of action, whether in contract, warranty, strict liability or tort, including negligence of any kind, in respect of this rebate.
15. Customer and Installer are both responsible for complying with any applicable federal, state, local and municipal laws and regulations, as well as any applicable property owner and/or homeowner’s association requirements (if any) regarding local conditions, restrictions, codes, ordinances, rules, and regulations, concerning this installation.
16. This program is funded by California utility customers and administered by SDG&E under the auspices of the California Public Utilities Commission. Rebates are provided on a first-come, first-served basis until program funds are no longer available.
